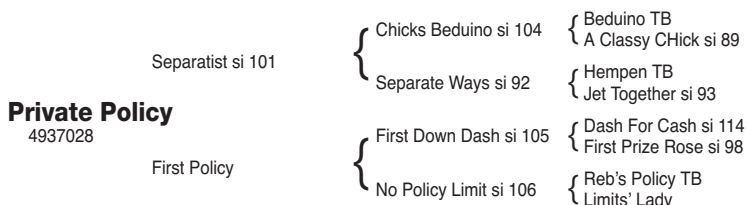

REBS LIMITS (g. by Reb's Policy TB). 3 wins, \$42,856, Gold Rush 870 D.
Merridocs Limits si 103 (g. by Merridoc). 9 wins \$90,230, 2nd Endurance H.-G3, etc.
